Grupo Jorge, together with its personnel, is expressly committed to complying with regulations as well as to improving continuously within the framework of transparency, with respect to all clients,, nearby local communities and authorities, always guaranteeing fair competition and business stability.

Our Environmental Policy defines this commitment to carrying out our activity within the parameters of sustainable development, maintaining control and management of environmental aspects, and guaranteeing a good business image with relation to environmental protection.

To fulfill these commitments and achieve the established objectives, the Management has established the following fundamental principles:

- Work in a way that is respectful of the environment and ensure its protection by taking up
 measures that are necessary to avoid the risk of environmental contamination and to minimize
 any environmental effects produced as a consequence of our activity, through the continuous
 improvement of processes, products and services.
- Ensure compliance with applicable environmental legal requirements and other requirements subscribed to by the organization in environmental matters.
- Bring the Environmental Management System closer to the entire organization to encourage the active participation of all employees in order to promote continuous improvement.
- A clear and unavoidable commitment on the part of the Management to implement and maintain the System of Environmental Management and disseminate these commitments at all levels of the organization.
- Give priority to prevention criteria over correction criteria in our performance principles.
- Maintain the awareness of all our employees, offering them training on the environment.
- Carry out a periodic annual evaluation of the environmental aspects derived from our activity, with the aim of maintaining and continuously improving the Environmental Management System.
- Minimize the use of natural resources and raw materials, prioritizing reuse and recycling, working towards circular economy in our processes.
- Ensure the protection of the environment that surrounds us; water, biodiversity, soil, atmosphere and society.
- Define concrete and measurable objectives and goals within an environmental program, whose achievements will be reviewed at least once a year.
- Guarantee the necessary resources to be able to adequately carry out all the tasks that make up environmental management.
- Ensure a profitable and socially just ecological transition.









All personnel are responsible for achieving environmental requirements, so management of the Environment is the result of the efforts of everyone.

All the people who make up Grupo Jorge accept these principles, and it is their responsibility to carry them out in practice.

Grupo Jorge is committed to achieving specific objectives in order to improve its impact on the environment, in alignment with the 2030 agenda and the 6 environmental objectives that make up the green taxonomy.

The Sustainable Development Goals prioritized in our strategic plan are certified annually by an external body.

- Reduction of water consumption in the Industry through improvements in processes and equipment up to 5.08 m³/Tn produced in 2026.
 This value represents a reduction in water consumption compared to production of 6.6% since 2019.
- Reduction of the Organization's Carbon Footprint (Scopes 1 and 2) down to 0.237 Tn Co₂/Tn produced in 2026. This represents a reduction of 22.4% since 2019. The Management will promote environmental improvement, and will allocate the necessary resources to ensure the successful implementation of the company's environmental policy.

The Management of Grupo Jorge, through the Environment Department, will broadcast this Environmental Policy in such a way that it is understood and acted on by all who make up the Organization.
