## **Our Commitment**

Grupo Jorge has a Sustainability Policy that defines the commitment to carry out our other activity within the parameters of sustainable development, integrating ESG criteria into the business decision processes and the strategic plan.

Grupo Jorge expressly commits itself, together with its work force, in accordance with current regulations, to continuous improvement, within the framework of transparency, where the group of clients, local community groups and authorities are involved, always guaranteeing fair competition and business stability.

- Favor the reduction of food waste by promoting actions that seek to eradicate hunger and ensure a healthy environment.
- Protect diversity and effective equality by promoting our equality plans and guaranteeing people's professional development.





- Integrate ESG management into the governing bodies through a business policy based on ethics, fiscal transparency and anti-corruption measures.
- Seek efficiency in the use of natural resources, reducing consumption, aiming for self management in all processes and managing waste through prevention, reduction, recycling and reuse.
- Carry out our activity maintaining respect for ecosystems and the preservation of biodiversity as an essential requirement.
